The selection committee comprises several eminent Canadian professors. The competition is therefore an ideal opportunity to be read by leading experts in international criminal justice. Blog posts will be selected according to originality and rigour both of the form and content. The three best submissions, as chosen by the selection committee, will be rewarded with prizes of \$500, \$250 and \$100 respectively. Blog posts must be submitted in .doc or .docx format and follow the *Quid Justitiae* guidelines reproduced below, otherwise they will not be considered.

# Guidelines of the Blog Quid Justitiae

Your blog post must adhere to the following guidelines:

#### Language

The *Quid Justitiae* blog is francophone, although the blog posts written in English and in Spanish will also be accepted, depending on the availability of the bilingual correctors on the Revision Committee.

#### **References and methodology**

Sources that can be consulted **for free** on the internet **must** be included within the text using hyperlinks (e.g.: "<u>Rome Statute</u> is [...]"). If it is difficult to include a free digital source with one word or several words in your text, you can use a label such as "(<u>here</u>)" or "(<u>for more information</u>)" after the relevant statement, and then add the appropriate hyperlink.

If the source either exists on the Web but is not available for free or if it does not exist on the Web or if you want to add further details, use a footnote.

For this, it is recommended to use the *Canadian Guide to Uniform Legal Citation (McGill Manual)*, though using another method will also be accepted, as long as it is used in a uniform manner (you must mention it when you submit your blog post).

Number of words	Maximum of 2500 words

The following settings must be respected :

### Content and mandatory information

Some useful information for formatting and blog post identification must be provided and grouped in a two-column table. The table must be placed at the top of the blog post.
