## Initial Appearance

### 1. Remarks / Remarques

- a. The Chamber started the proceedings at 9:10 a.m. to hear the plea of the Accused. However, the Chamber had to adjourn from 9:20 to 9:40 a.m. in order to enable the Accused to be read the Indictment in his own language, Kinyarwanda, by the Kinyarwanda Interpreter. The Chamber did so after the accused said that he had received the Indictment in Kinyarwanda but could not read it since he has sight problems.
- b. The proceedings resumed at 9:40 a.m. and Mr. Kouambo from the Registry read the Indictment.
- c. When called to enter a plea to the charges by Judge Byron, the Accused pleaded not guilty with respect to all the three Counts, namely: Genocide, crime stipulated in Articles 2(3)(a) of the Statute, Conspiracy to Commit Genocide, a crime stipulated in Article 2(3)(b) of the Statute and Extermination as a crime against Humanity, as stipulated in Article 3(b) of the Statute.
- d. The Chamber then asked the Parties if they had anything to say before the rising of the Court. The parties said they did not have anything to say.
- e. The Chamber thanked all the parties and ended the proceedings at 10:00 a.m. See the direction of the Chamber at paragraph 2a.
